
**A RESOLUTION OF THE BOARD OF DIRECTORS

NOW, THEREFORE, BE IT RESOLVED THAT, in accordance with California Code Regulations, Title 2, Section 570.5, the Board of Directors of the Midway City Sanitary District hereby adopts the Salary Schedule, Effective July 1, 2022 – June 30, 2023, which is attached hereto as Exhibit A.


